Alumni Day Seminar

Cardiovascular Pharmacotherapy: Important Changes Over the Last 5 Years (Application-based)

- Select appropriate guideline-based treatment goals and pharmacotherapy recommendations for the management of hyperlipidemia and hypertension.
- Identify appropriate treatment scenarios utilizing the direct acting oral anticoagulants (DOACs) and potential anticoagulant reversal options for these agents.
- Utilize recent literature and the most recent set of heart failure guidelines to select appropriate pharmacotherapeutic regimens regarding heart failure management.

Painting Community Pharmacy’s Future: The Opportunity of Community Pharmacy Enhanced Services Networks (Knowledge-based)

- Review the current healthcare landscape and the conundrum and opportunity it presents for community pharmacy in population health and value-based care models.
- Discuss how to evaluate the benefits of a Community Pharmacy Enhanced Services Network (CPESN) model in a value-based health care environment and how it can benefit community pharmacy participants.
- Discuss learnings from emerging CPESN networks in other states.

Update on Pharmacist Provider Status Legislation (Knowledge-based)

- Give an update on the status of proposed federal legislation that would recognize pharmacists as health care providers.
- Explain how pharmacists can become involved in advocacy effects regarding pharmacist provider status.

Pharmacists Role in Assessing Risk and Preventing Hepatitis B Viral Infection (Knowledge-based)

- Describe the etiology and pathogenesis of hepatitis B virus infection.
- Discuss signs and symptoms of acute and chronic hepatitis B infection.
- List risk factors for contracting hepatitis B infection.
- Outline current immunization recommendations for children and adults for the hepatitis B vaccination series.
- Summarize the risk faced by West Virginian’s based on current available data.
- Describe a plan for pharmacist involvement in improvement of preventative care for hepatitis b in the state of West Virginia.

Updates in HIV Therapy (Knowledge-based)

- Describe the pathophysiology of HIV infection Identify the first line drugs indicated for treatment.
- State new developments in antiretroviral therapy.
- Discuss acute HIV infection and the kick and kill strategy to cure HIV.

Flatwoods Seminar

**Updates in Prescription Drug Diversion, Substance Use Disorders, and Pain Management, and Managing Patients Prescribed Buprenorphine and Naloxone Products (Application-based)

- Discuss what comprises drug diversion, including West Virginia statistics on prescription drug abuse and resulting deaths
- State the epidemiology of chronic pain and misuse of opioids
- Describe the indicators for opioids in chronic pain treatment including general characteristics, toxicities and drug interactions
- Outline patient evaluation and risk assessment and tools to assess risk and monitor benefits
- Explain the initiation and ongoing-management of chronic pain in patients treated with opioid based therapies
- Discuss a case study of a patient with chronic pain
- Identify diversion and drug seeking behaviors and tactics
- State best practice methods for working with patients, prescribers and law enforcement concerning patients suspected of drug-seeking behavior and diversion
- Give examples of compliance with controlled substances laws
- Identify registration with and use of the West Virginia Controlled Substances Monitoring Program established in West Virginia Code 60A-9-1
- Define specific indications and rationales for use of buprenorphine products.
- Communicate optimal pain management considerations to prescribers of buprenorphine products.
- Review the dispensing guidelines on naloxone products to concerned individuals of potential overdose patients.

An Ounce of Prevention: A 2017 Immunization Update (Application–based)

- Apply recent Advisory Committee on Immunization Practice guidelines for adult vaccinations to clinical practice.
- Differentiate between available influenza, tetanus-containing, pneumococcal, and meningococcal vaccines and determine how to select the most appropriate vaccine.
- Identify HPV vaccination recommendations for adolescents and adults.
- Discuss challenges in providing vaccinations to the adolescent population.

- Discuss regulation, legislation and accreditation organizations related to antimicrobial stewardship.
