In addition to direct patient care, the clinical pharmacists lead quality improvement initiatives, precepted learners, and served on department and hospital committees and workgroups to advance the practice of pharmacy and raise the quality of patient care at WVUH.

Clinical Pharmacy Services

Ambulatory Care

The Ambulatory Care Adult Clinical Services pharmacy division comprises all specialist pharmacists providing care in outpatient clinics for adult patients. A dynamic team of six ambulatory and three hybrid clinical pharmacists practice in six primary care and specialty clinics, with many in the process of establishing collaborative practice agreements with the clinic providers. Work towards establishing pharmacist referral services and scheduling was led by pharmacists, building the foundation for advancing the level of clinical services provided.



Acute Care

The Acute Care Adult Clinical Services pharmacy division comprises all adult inpatient medical and surgical service areas and their related specialty areas. It is composed of sixteen clinical generalist pharmacists and twenty-seven clinical specialist pharmacists providing around-the-clock pharmacy services for 75 adult services. Clinical pharmacists are integrated into patient care teams as part of a practice model consisting of service line-based coverage, with clinical pharmacists predominantly decentralized. Clinical pharmacists participate in daily interdisciplinary patient care rounds for most medical services in addition to order verification duties, management of pharmacist-owned protocols, emergency response, and other patient care activities.

Clinical Pharmacy Services (Cont.)

Oncology

The Adult Oncology Pharmacy Division provides comprehensive clinical and operational pharmacy services for inpatient and ambulatory patients receiving oncology therapy as well as all clinical trials involving investigational medication therapy at WVUH. The division is composed of 20 clinical pharmacists and 9 pharmacy technicians dedicated to providing the highest quality of pharmacy services and education for our patients and clinical teams. Clinical pharmacists are integrated into the patient care team within both the inpatient and ambulatory sites of oncology care. The pharmacy technicians within the oncology division combine meticulous compounding technique and utilization of sterile compounding workflow technology to ensure the highest level of safety and accuracy in medication preparation for our patients.

Clinical Pharmacy Programs

Antithrombotic Stewardship Program

The Antithrombotic Stewardship Program (ASP) is dedicated to enhancing the safety and quality of antithrombotic use across the continuum of care of WVU Hospitals. Established in 2021, this team is comprised of two clinical specialist pharmacists, one clinical pharmacy technician, and is overseen by a physician medical director. The ASP team works collaboratively with clinical pharmacists and medical staff to positively impact the safe and effective utilization of antithrombotic medications and achieve optimal patient outcomes while minimizing harm.





Medication History Technican Program

The Medication History Technician (MHT) Program works in tandem with clinical pharmacists and pharmacy interns to complete accurate medication histories for all medium and highrisk patients upon admission. The MHT team is comprised of ten clinical pharmacy technicians assigned to most inpatient medical teams and is led by one technician supervisor. The work conducted by the MHT team is pivotal for providing the team with the information needed to ensure safe and appropriate medication management for patients.

Clinical Pharmacy Programs

Outpatient Antimicrobal Therapy Program

The Outpatient Antimicrobal Therapy Program (OPAT) improves the health of the community by providing improved access to antibiotic treatment. Highlights of the OPAT program are:


- Decreased antibiotic days for targeted Diagnosis Related Groups by 2 days (13 days to 11 days)
- Decreased antibiotic spend for targeted Diagnosis Related
 Groups to below median value compared to Vizient
 Academic Medical Centers
- Decreased antibiotic spend per 1,000 patient days by 28% resulting in over \$1 million in cost avoidance
- Recognized by the WV Rural Health Association as a 2021
 West Virginia Rural Health Leader
- Contributed to the scientific body of literature, including a publication on outpatient intravenous and complex oral antibiotic therapy



INPATIENT OPERATIONS

The Pharmacy Operations team oversees the medication use process at WVU Hospitals, ensuring reliable and safe distribution of medications to patients. This team oversees the procurement, storage, preparation, distribution, and delivery of medications throughout WVU Hospitals. Our time and service are dedicated to operating the central pharmacy, including the IV room, controlled substance vault, and perioperative services. The pharmacy operations team is comprised of highly experienced and dedicated technicians, interns, pharmacists, and leaders to meet the needs of patients at WVU Hospitals.

MEDICATION USE, QUALITY, AND COMPLIANCE

The focus of WVU Medicine Health System Medication Use Team is to collaborate with healthcare professionals to promote the safe and effective use of medications for our patients. This is achieved through integration with clinical and operational staff, as well as those in medication safety, informatics and pharmacy administration. Medication Use is directly responsible for assessing the clinical and safety impact of medications, forecasting future drug therapies, performing and assisting clinicians in the execution of medication use evaluations and other benchmarking strategies.

Medication Use is also responsible for the coordination of the WVU Medicine Health System Pharmacy & Therapeutics (eP&T) Committee, in addition to the eight subcommittees focusing on ambulatory care, hematology/oncology, critical care, perioperative services, antithrombotic stewardship, anti-microbial stewardship, formulary standardization and medication safety.

HIGHLIGHTS

The Medication Use assisted with the COVID-19 therapeutics, including vaccine and monoclonal antibody guidance and the development of appropriate criteria for use in an effort to support front-line clinicians during the global pandemic. In addition, other activities included:

- 25 guidelines developed and/or revised in collaboration with clinical pharmacy staff
- 11 drug class reviews
- 6 criteria for use revisions
- Implementation of a therapeutic interchange for 25 drug classes
- · 6 pharmacist protocol orders implemented
- Project oversight for 18 resident Medication Use Evaluation (MUE)

MEDICATION USE, QUALITY, AND COMPLIANCE

Specific initiatives the Medication Use Team focused on included:

- Evaluated all formulary requests and performing continuous formulary management services
- Developed appropriate medication criteria for use
- Facilitated clinical practice and guideline reconciliation
- Provided clinical support surrounding drug shortages and recalls
- Integrated with the West Virginia Center for Drug and Health Information to expand drug information support services
- Formed the Gene and Cellular Therapy Taskforce to assist with complex and costly medication regimens surrounding CAR-T therapies and Exon Skipping Therapies

- Addition of a Drug Diversion Coordinator position
- Creted the WVUH Oversight Committee
- Bluesight software implemented

340B MANAGEMENT PROGRAM

Enterprise 340B Program Management is responsible for performing all duties associated with administering the 340B program at WVU Medicine in alignment with current rules and regulations outlined by the Health Resources and Services Administration (HRSA) and the Office of Pharmacy Affairs (OPA). The goal of the Program is to ensure program compliance, maximize efficiencies, determine areas of growth and improvement, and support leadership of WVUHS

The goal is to simplify and improve the treatment process.

Launched in August and received clean room certification with Fil-Tech in October 2021.

WV Board of Pharmacy approved clean room inspection and awarded Allied Health Solutions Sterile Compounding Licensure in November 2021.

Allied Health Solution Home Infusion Pharmacy was credentialed with WV Highmark Blue Cross Blue Shield for Home infusion services In November 2021.

AHS Home Infusion is partnered with CarepathRx for the intake, billing, and clinical management aspects of Home Infusion Pharmacy Services.

AHS Home Infusion's 'soft-launch' started with a focus on Rheumatology, GI, and Immunology disease states. Goals for 2022 include an expanded focus to additional specialty clinics and medications, including but not limited to Neurology with Ocrevus and Vyepti, Opthamology with Tepezza, and Hyperlipidemia with Evkeeza.

Infusion Pharmacy Services accreditation via ACHC is currently in pursuit with a virtual survey visit expected in early Jan 2022. This accreditation will open the door to additional insurance providers and patients beyond the current demographic of specialty infusion medications through WV Medicaid, Medicare Part D, and WV Highmark BCBS.

RETAIL PHARMACY SERVICES

Retail Pharmacy Services comprises three retail pharmacies in the Morgantown area. Two are located on-campus at Ruby Memorial Hospital and the third at the WVU Health and Education Building. We are dedicated to providing the best care for patients, employees, and other guests of WVU Medicine. We are passionate about caring beyond the prescription and providing highquality care. Our emphasis is on providing timely, safe, and accurate prescription services while educating patients on the importance of their medication.



RESIDENCY CLASS OF 2021-2022

The WVU Medicine Pharmacy Residency Program was started in 1985 by then Residency Coordinator, Art Poremba, and accredited by ASHP in 1987. Since its inception, 127 residents have completed the PGY-1 program. Since the program's inception, 36 classes have completed the program, consisting of nearly 200 residents. The program continues to gain national exposure, having had residents originally from schools located in nearly half of the 50 states. In 2021, four PGY-2 graduates from the 2020-2021 class accepted positions at WVU Medicine.

2021 Residency Program Highlights

- The PGY-1 Pharmacy Practice (Specialty-focus) residency graduated its first resident and completed the ASHP residency accreditation survey
- Approval of a PGY-2 Cardiology residency and a PGY-2 Ambulatory residency, slated to begin in 2022





Pharmacy Residency and Education

Pharmacy Interns

Pharmacy interns are employed throughout the hospital to support the functions of the departments in which they are employed while gaining valuable practical experience. Pharmacy interns work directly with patients conducting medication histories and staffing supportive technical functions. They also participate in a resident-student mentoring program and have the opportunity to complete medication use projects to present at conferences.

Pharmacy Students

WVU Hospitals' Department of Pharmacy has a strong commitment to education. We offer advanced pharmacy practice experience (APPE) rotations across all practice settings such as acute and ambulatory care clinical practice, community practice, administration, and other specialized electives. The department also hosts an application-based longitudinal track program for APPE rotations designed to emphasize residency preparation. There are also community and institution introductory pharmacy practice experiences offered to WVU School of Pharmacy students.

HIGHLIGHTS

- WVUH pharmacists precepted 120 WVU SOP student experiential rotations in 2021
- Fifteen WVU SOP students completed the longitudinal APPE track in 2020-2021, with another cohort of fifteen students beginning the track in 2021-2022
- The department increased number of APPE rotations available to WVU SOP students to provide more clinical training opportunities for students interested in residency
- WVUH preceptors led a residency preparation series for all fourth-year students


