ACTIVITY DESCRIPTION

This knowledge-based live webinar activity, designed for pharmacists, will focus on drug diversion prevention.

This program meets the requirement for pharmacists in their first-year renewal and/or reciprocating to West Virginia. The 2023 Legislature passed a law that was implemented during the 2024 license renewal cycle for pharmacists regarding the Drug Diversion Continuing Education (CE) requirement. This law update only requires pharmacists to complete the Drug Diversion CE one time within one year after initial licensure. If you have reported Drug Diversion CE to the WV BOP during a licensure renewal before 2024 you DO NOT need to report the Drug Diversion CE requirement in 2024.

PHARMACISTS LEARNING OBJECTIVES

- Recall common “Red Flags” and general controlled substance concerns for prescribers and dispensers.
- Recognize applicable federal laws dictating how to dispense controlled substances.
- Recall West Virginia CSMP requirements and reported trends.
- Discuss how to use the morphine milligram equivalent (MME) factors of common prescription opioids to calculate MME/Day dosages.
- Identify the available prescription and over-the-counter opioid antagonist products currently available in the United States and the respective administration techniques.
- Recall the pharmacological properties of buprenorphine relevant to patient care.
